_____ I will be charged for Winter Showcase costumes on 10/01/09, and Spring Showcase costumes on 02/01/10 unless
I complete and turn in an Opt-Out Form by the 25th of the month prior to the costume charge date.

_____ ***If I wish to drop a class I must notify Dance Elite by filling out a Withdrawal Form or a Class Change Form in person by the 15th of the month in order to stop the automatic payment for the following month.***

_____ Dance Elite communicates through e-mail, and I am responsible for keeping and checking a current e-mail account in order
to receive updates, etc. It is also my responsibility to check the bulletin board and Parent Communication Folder for any
announcements I may have missed through e-mail.

_____ Missed classes must be made up within 30 days in a class at a level equal to or lower than my child's original class.
